2. e. The *Judicial Committee* will
 - a. Review the city zoning code and related ordinances relative to requirements that parking lots have "hard surfacing."
 - b. Requirements for perpendicular signs will also be reviewed considering the code and ODOT regulations. The Mayor plans to publicize the city's code enforcement strategy with initial efforts aimed at educating possible violators about code requirements and assisting them in understanding appropriate remedial actions.
 - c. Council members asked to receive copies of the notification letters which go to property owners whose sidewalks are in violation of city code. Council's desire is to understand current procedure and review if policy changes might be necessary for pedestrian safety. The Judicial Committee may collaborate with the *Service Committee* in researching a method by which the city may make available a contracted service to assist property owners who want to bring their sidewalks into compliance.
