Food Truck License Requirements

To obtain a license, the following information is required:

- Proof of Ohio Department of Taxation Transient Vendor's License, if required by State law
- Copy of current and valid state vehicle registration information for the unit proposed to be permitted for food service operation
- Proof of current and valid license issued by the applicable department of health pursuant to the Ohio Revised Code to conduct retail food operations
- Federal Tax Identification number of Social Security Number if no Federal Tax Identification number is available. If the applicant is not current and compliant in the payment of any taxes on payroll and net profits, proof that the applicant has entered into an agreement to pay any delinquency and is abiding by the terms of the agreement is required at the time this application is submitted.
- Proof of liability and property damage insurance. Limits of such coverage shall not be less than \$300,000 for Food Carts and not less than \$1,000,000 for Food Trucks/Trailers.
- Inspection and approval of all fire extinguishers by the Circleville Fire Department
- Payment of a Food Cart and Food Truck/Trailer License:
