The Finance Committee handles the annual budget for the city, expenditures from unappropriated funds, alternative revenues sources and methods, internal fiscal compliance, issuance and rollover of notes, funding for new positions, wage, salary and benefit adjustments, and income tax collection.

1. Approval of Finance Committee minutes from June 4, 2024.

2. New Business:

a) RESOLUTION TO SUBMIT TO THE ELECTORS AT A GENERAL ELECTION TO BE HELD ON NOVEMBER 5, 2024, AN ORDINANCE TO REPLACE THE ONE-HALF PERCENT (.50%) INCOME TAX RATE INCREASE ALLOCATED FOR THE PURPOSE OF OPERATING AND MAINTAINING THE SAFETY FORCES IN THE CITY OF CIRCLEVILLE, TO BE EXPENDED FOR THE SAFETY FORCES PRIOR TO THE FUNDS ALLOCATED TO THE GENERAL FUND, WITH A 0.40% PER ANNUM INCOME TAX FOR A FIVE-YEAR PERIOD TO COMMENCE JANUARY 1, 2025 AND EXPIRING DECEMBER 31, 2029, DIRECTING THE PICKAWAY COUNTY BOARD OF ELECTIONS TO SUBMIT THE TAX ORDINANCE TO THE ELECTORS OF THE CITY PURSUANT TO OHIO REVISED CODE, SECTION 718.04 AND DECLARING AN EMERGENCY.

b) AN ORDINANCE REPLACING THE ONE-HALF PERCENT (.50%) INCOME TAX RATE INCREASE ALLOCATED FOR THE PURPOSE OF OPERATING AND MAINTAINING THE SAFETY FORCES IN THE CITY OF CIRCLEVILLE, TO BE EXPENDED FOR THE SAFETY FORCES PRIOR TO THE USE OF THE FUNDS ALLOCATED TO THE GENERAL FUND, WITH A 0.40% PER ANNUM INCOME TAX FOR A FIVE YEAR PERIOD, EFFECTIVE FROM JANUARY 1, 2025 AND EXPIRING DECEMBER 31, 2029, DIRECTING THE PICKAWAY COUNTY BOARD OF ELECTIONS TO SUBMIT THIS ORDINANCE TO THE ELECTORS OF THE CITY PURSUANT TO OHIO REVISED CODE, SECTION 718.04 AND DECLARING AN EMERGENCY.

c) AN ORDINANCE TO AUTHORIZE AND IMPLEMENT THE LABOR AGREEMENT BETWEEN THE NON-UNIFORMED EMPLOYEES' ORGANIZATION AND THE CITY OF CIRCLEVILLE.

d) AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION ORDINANCE IN THE GENERAL FUND 101 SPECIALIZED DOCKET SUBSIDY GRANT FUND 266 AND CAPITAL IMPROVEMENT FUND 306 OF THE CITY OF CIRCLEVILLE
