

RECORD OF ORDINANCES

Ordinance No. 03-18-2023 Passed 3-7-, 20 23

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ENTER INTO AN AGREEMENT WITH THE DURABLE RESTORATION COMPANY, 3933 GROVES RD. COLUMBUS, OHIO 43232, TO RECONSTRUCT AND RESTORE THE EXISTING BELVEDERE STRUCTURE ON TOP OF CITY HALL, OBVIATING FORMAL BIDDING AND ADVERTISING AND DECLARING AN EMERGENCY

WHEREAS, The Belvedere structure located on top of City Hall is in desperate need of repair and is in danger of creating hazardous conditions for the property surrounding City Hall and the public on the Right of Ways adjacent to City Hall and

WHEREAS, The Belvedere structure is a crucial piece of history in the Historic District of the City of Circleville and

WHEREAS, The City is desirous of restoring the Belvedere to it's historic condition and having the original City Hall bell re-installed in the Belvedere and

WHEREAS, the process of restoration is specialized and requires expertise in this area which can be provided by The Durable Restoration Company and

WHEREAS, due to the emergency need to replace the Belvedere it is necessary to enter into the contract for the restoration without formal bidding and advertising as permitted by O.R.C.735.051;

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Circleville. County of Pickaway, State of Ohio, as follows:

SECTION I: That the Director of Public Service is hereby authorized to enter into an agreement to reconstruct and restore the Belvedere on City Hall with The Durable Restoration Company (Attachment A) due to the real and present emergency arising out of the current dilapidated condition of the Belvedere.

SECTION II: That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health or safety of the citizens of the City of Circleville, such emergency arising out of the immediate need to begin the reconstruction and restoration of the dilapidated Belvedere so that this ordinance shall take effect and be in force immediately after its passage and approval by the Mayor.
