AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION ORDINANCE IN THE GENERAL FUND 101 SAFETY FORCES .5% TAX FUND 212 ARPA FEDERAL GRANT FUND 257 OF THE CITY OF CIRCLEVILLE.
