

# RECORD OF ORDINANCES

Ordinance No. 09-65-2024 Passed 9-3, 2024

**AN ORDINANCE AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE TO SUBMIT AN APPLICATION AND ENTER INTO AN AGREEMENT WITH THE STATE OF OHIO FOR STATE CAPITAL IMPROVEMENT PROGRAM (SCIP) AND LOCAL TRANSPORTATION IMPROVEMENT PROGRAM (LTIP) FUNDS, FOR THE STREET IMPROVEMENT PROJECT 2025.**

**WHEREAS**, District 17 Integrating Committee is authorized to provide financial assistance to units of general local government for undertaking and carrying out local improvement activities; and

**WHEREAS**, the road and utility improvements for Street Improvement Project 2025, fit the criteria necessary for SCIP and LTIP Funding; and

**WHEREAS**, the members of the Council of the City of Circleville have general knowledge of the proposed use of such funds and are cognizant of the conditions that are imposed in the undertaking and carrying out of these activities with state financial assistance under the State Capital Improvements Program, including those prohibiting discrimination because of race, color, creed, sex, or national origin.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, COUNTY OF PICKAWAY, STATE OF OHIO AS FOLLOWS:**

**SECTION I.** That the Director of Public Service of the City of Circleville is hereby authorized to file an application for funds from the District 17 Integrating Committee, for the road and utility improvements for Street Improvement Project 2025, which fit the criteria for funding, and provide all information and assurances as may be necessary under the State Capital Improvements Program and Local Transportation Improvement Program.

**SECTION II.** That the Director of Public Service of the City of Circleville is hereby authorized to enter into an agreement with the State of Ohio for financial assistance under the OPWC Grant Funding for Round 39 of State Capital Improvement Program and Local Transportation Improvement Program.

**SECTION III.** That the Director of Public Service of the City of Circleville is hereby authorized to execute and carry out all programs, bids, contracts and all other activities set forth in the agreement.

**SECTION IV.** That this ordinance shall take effect and be in force at the earliest period allowed by law.
