c) AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ENTER INTO A CLEAN OHIO GREEN SPACE CONSERVATION PROGRAM GRANT AGREEMENT WITH THE OHIO PUBLIC WORKS COMMISSION TO PROVIDE GRANT FUNDS TO IMPROVE LOCAL ENVIRONMENT FOR THE CITY OF CIRCLEVILLE AND DECLARING AN EMERGENCY.
