# RECORD OF ORDINANCES

Ordinance No. 05-31- 2023 Passed 5-2, 2023

**AN ORDINANCE TO AMEND ORDINANCE NUMBER 02-07-2017 AUTHORIZING THE MAYOR OF THE CITY OF CIRCLEVILLE TO CHANGE THE PLEDGE AMOUNT AND ENTER INTO A PLEDGE AGREEMENT FOR ECONOMIC DEVELOPMENT SERVICES WITH PICKAWAY PROGRESS PARTNERSHIP.**

**WHEREAS**, it is necessary to contract with Pickaway Progress Partnership (hereinafter referred to as P3) to be responsible for encouraging business and industry to remain and relocate into the City of Circleville and Pickaway County; and

**WHEREAS**, various private and public sector organizations have agreed to assist in funding the economic development efforts of P3; and

**WHEREAS**, the Council of the City of Circleville desires to pledge an additional \$3,000.00 per year for (5) years, beginning 2022<sup>3</sup> and ending 2027 with a total support of \$60,000.00 at the end of the period as its portion of funding for P3; and

**WHEREAS**, P3 agrees to maintain the City's 'site and building database, attract new business to the community through its marketing efforts, work to retain the City's existing industry, negotiate incentives with companies on the City's behalf to encourage job growth and retention, and work to implement the City's Comprehensive Plan for development; and

**WHEREAS**, the Council is therefore desirous of authorizing the Mayor of the City of Circleville to enter into a pledge agreement on the behalf of the City with P3 to provide economic services on behalf of the City.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Circleville, County of Pickaway, State of Ohio, as follows:

**SECTION I:** That the Mayor of the City of Circleville is hereby authorized to enter into a pledge agreement for economic development services with P3 under the terms of which the City of Circleville desires to pledge an additional \$3,000.00 per year for (5) years, beginning 2022<sup>3</sup> and ending 2027 with a total support of \$60,000.00 at the end of the period as its portion of funding for P3.

**SECTION II:** That there is hereby authorized the expenditure of an additional \$3,000.00 per year for (5) years, beginning 2022<sup>3</sup> and ending 2027 with a total support of \$60,000.00 to be used for the payment of Pickaway Progress Partnership, which amounts shall be paid from Account# 101.0712.55010 – Contract Services.

**SECTION III:** That this Ordinance shall take effect and be in force from and after the earliest period permitted by law.
