ORDINANCE NO. 10-93-92

AN ORDINANCE ACCEPTING AN APPLICATION FOR ANNEXATION, AND DECLARING AN EMERGENCY.

WHEREAS, individual property owners have petitioned the Board of Pickaway County Commissioners for annexation of certain property to the City of Circleville, Ohio, and

WHEREAS, such petition has been properly passed and certified to the Clerk of Council of the City of Circleville, Ohio, and

WHEREAS, such transcript has been certified to the Clerk of the Council of the City of Circleville for a period of not less than 60 nor more than 180 days; NOW, THEREFORE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, STATE OF OHIO:

SECTION I. That the application of Scott Clifton, petitioner, be accepted for the annexation of the following described territory in the County of Pickaway and adjacent to the City of Circleville, Ohio, to-wit:
