AAN ORDINANCE ESTABLISHING REGULATIONS FOR SNOW REMOVAL AND DECLARING AN EMERGENCY

WHEREAS, in order to facilitate the cleaning of streets, to expedite the free flow of vehicular traffic, and to otherwise protect the citizens of the City of Circleville in case of an emergency following any snow accumulation, the Council of the City of Circleville, has determined it necessary to establish certain regulations for snow removal by private citizens and contractors; and

WHEREAS, the Council of the City of Circleville is empowered by statute to create regulations relating to snow removal so as to protect the health and safety of the citizens of the City; and

WHEREAS, said regulations of snow removal would not be detrimental to the citizens of the City and the same ought to be done;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Circleville, Pickaway County, Ohio as follows:

SECTION I REGULATIONS FOR SNOW REMOVAL

Snow removal by private citizens and contractors within the City of Circleville shall be completed in such a manner so as to facilitate the cleaning of streets, expedite the free flow of vehicular traffic, and otherwise protect the citizens of the City in the event of any emergency. For this purpose, the following regulations are hereby provided to, and at all times be followed by the citizens of the City of Circleville subject to the penalties hereinafter set forth:

- A) No person shall place or cause to be placed snow from any driveway, curb, sidewalk, or parking lot onto any street, highway, thoroughfare, alley or public roadway in such a manner that it hinders the cleaning of streets or obstructs the safe and free flow of vehicular traffic.
- B) No person shall place or cause to be placed any snow in front of or around any fire hydrant or storm sewer within the City.

SECTION II PENALTY

Any person or persons violating the provisions of this Ordinance is hereby guilty of a minor misdemeanor, with each day being a separate violation.

SECTION III

This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the inhabitants of the City of Circleville for the reason that the cleaning of streets and free flow of vehicular traffic must at all times be protected to insure the safety of the citizens after any snowfall, so that this Ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor.
