ORDINANCE NO. 10-70-93

AN ORDINANCE AUTHORIZING THE MAYOR AND CITY LAW DIRECTOR OF THE CITY OF CIRCLEVILLE TO ENTER INTO A CONTRACT WITH THE PICKAWAY COUNTY COMMISSIONERS FOR THE CITY OF CIRCLEVILLE BUILDING DEPARTMENT TO PROVIDE SERVICES TO THE PICKAWAY COUNTY BUILDING DEPARTMENT AND DECLARING AN EMERGENCY

WHEREAS, the Council of the City of Circleville is empowered by statute to create a building department and to permit said department to assist the Board of Commissioners of Pickaway County in the administration and enforcement of the County building regulations; and

WHEREAS, the Board of Commissioners of Pickaway County, Ohio has requested the services of the City of Circleville Building Department pursuant to Ohio Revised Code, § 307.38 to assist in the administration and enforcement of the county building regulations and is willing to enter into a contract with the City of Circleville to pay for such services; and

WHEREAS, the Council of the City of Circleville deems it to be in the best interests of its citizens to permit the Mayor and City Law Director to enter into a contract to provide for these services and that the same ought to be done;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Circleville, Pickaway County, Ohio as follows:

SECTION I: That the Mayor and City Law Director of the City of Circleville is hereby authorized to negotiate and enter into a contract with the Board of Commissioners of Pickaway County, Ohio pursuant to Ohio Revised Code § 307.38 to permit the City of Circleville Building Department to provide services in the administration and enforcement of the building regulations of the county building department, said contract to be under such terms and subject to such conditions as the Mayor and City Law Director deem to be in the best interests of the City of Circleville.

SECTION II: That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, and welfare of the citizens of the City of Circleville, such emergency arising out of the necessity to enter into a contract with the Board of Commissioners of Pickaway County immediately and without unnecessary delay, so that this ordinance shall take effect and be in force immediately upon its passage and approval by teh Mayor.
