AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO HAVE PLANS, SPECIFICATIONS, AND ESTIMATES OF COST PREPARED FOR THE INSTALLATION OF CURBS WITH GUTTERS, SIDEWALKS, STORM WATER SEWER, ALONG WITH THE INSTALLATION OF NEW BASE AND PAVEMENT ON SECOND AVENUE FROM SOUTH PICKAWAY STREET TO A NEW INTERSECTION WITH TOWN STREET BETWEEN SOUTH PICKAWAY AND SOUTH WASHINGTON STREETS; AND DECLARING AN EMERGENCY.

WHEREAS, Second Avenue, from South Pickaway Street to the current dead-end of Second Avenue, needs improved by installation of curb, with gutter, and sidewalk, storm water sewer, along with the installation of new base and pavement on the street; and

WHEREAS, City Council is in concurrence with such desire to improve this section of streets; NOW, THEREFORE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, STATE OF OHIO:

SECTION I. That the Director of Public Service is hereby authorized and directed to cause to be prepared plans, specifications, and cost estimates for the improvement of Second Avenue, from South Pickaway Street to a new intersection on Town Street between South Pickaway and South Washington Streets by the installation of curbs, gutters, sidewalks, storm water sewer thereon, along with the installation of new base and pavement on the street.

SECTION II. That, after completion of said plans, specifications, and costs, the Director of Public Service shall file said information with the Office of the Clerk of Council.

SECTION III. That the above actions shall be done in conformity with Chapter 727 of the Ohio Revised Code.

SECTION IV. That Council declares this to be an emergency ordinance necessary for the preservation of the public peace, health, and safety, such emergency arising out of the necessity to improve the said streets for the safety and protection of the general public without undue delay in order to correct a situation now deemed undesirable; wherefore, this ordinance shall take effect and be in force from and after its passage and approval by the Mayor.
