Ordinance No. 05 - 22 - 2621 Passed 5 - 18, 20, 21

A RESOLUTION AUTHORIZING THE DOWNTOWN BUSINESS ASSOCIATION RETAIL MERCHANTS AND THE PICKAWAY COUNTY WELCOME CENTER, DIVISIONS OF THE PICKAWAY COUNTY CHAMBER OF COMMERCE, TO UTILIZE A PORTION OF CITY SIDEWALKS, STREETS AND ALLEYS FOR THEIR EVENTS FOR 2021 AND DECLARING AN EMERGENCY.

WHEREAS The Pickaway County Welcome Center desires to use downtown sidewalks for their Be Local Buy Local Crawl on June 18 and 19, 2021.

WHEREAS the Downtown Business Association/Retail Merchants desire to use downtown sidewalks for their Sidewalk Sale-abration on July 15, 16 and 17, 2021.

WHEREAS the Downtown Business Association/Retail Merchants desire to use downtown sidewalks for their September Fair on September 18, 2021.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Circleville, County of Pickaway, State of Ohio, as follows:

SECTION I. That the Pickaway County Welcome Center be, and is hereby authorized to utilize downtown sidewalks on Court Street from Franklin Street to High Street and Main Street from Pickaway Street to Western Avenue on June 18 and 19, 2021 from 10:00 am until 6:00 pm for their Be Local Buy Local Crawl. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various sidewalks

SECTION II: That the Downtown Business Association/Retail Merchants be, and is hereby authorized to utilize downtown sidewalks on Court Street from Franklin Street to High Street and Main Street from Pickaway Street to Western Avenue on July 15, 16 and 17, 2021 from 10:00 am until 6:00 pm for their Sidewalk Sale-abration. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various sidewalks.

SECTION III: That the Downtown Business Association/Retail Merchants be, and is hereby authorized to utilize downtown sidewalks on Court Street from Franklin Street to High Street and Main Street from Pickaway Street to Western Avenue on September 18, 2021 from 10:00 am until 3:00 pm for their September Fair. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various sidewalks.

SECTION IV. That as a condition precedent to Section 1 and Section II, the event sponsor shall maintain a Two Million Dollar (\$2,000,000) Certificate of Liability Insurance for the protection of the City of Circleville, Ohio, indemnifying and saving harmless the said City, from any liability that may arise or accrue by reason of the temporary use of the sidewalks, streets and alleys the event sponsor shall present a copy of said insurance, naming the City as an additional insured, to the Auditor of the City of Circleville, Ohio for approval prior to said event..

SECTION V. That as a further condition precedent to this authorization, as set forth in Section I and Section II, the event sponsor shall comply with any and all Ohio Department of Health Safety Regulations and Guidelines in effect at the time of the event to reduce the potential for the spread of the COVID-19 virus.

SECTION VI. That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Circleville; the emergency being to avoid unnecessary delay in the application process; wherefore, this Resolution shall be in full force and effect immediately upon the passage
