**AN ORDINANCE AMENDING THE ANNUAL
APPROPRIATION ORDINANCE IN THE GENERAL GOVERNMENT FUND 101
AND SAFETY FORCES .5% TAX FUND 212
OF THE CITY OF CIRCLEVILLE**

Whereas, it is necessary to amend the annual permanent appropriation ordinance known as 03-11-2021; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, STATE OF OHIO:

SECTION 1: That the annual appropriation ordinance be amended in the **General Government FUND 101** by increasing a department function by the following amount:

SECTION 2: That the annual appropriation ordinance be amended in the **Safety Forces .5% Tax Fund 212** by increasing a department function by the following amount:

**Security of Persons Program 1
Fire Department 31**

Other Department Functions

Capital Outlay 3 \$10,493.68

Total Fire Department 31 \$10,493.68

Total Security of Persons Program 1 \$10,493.68

Total Safety Forces .5% Tax Fund 212 \$10,493.68

from the unappropriated monies of the **Safety Forces .5% Tax Fund 212** to the **Safety Forces .5% Tax Fund 212** department function as indicated.

SECTION 3: It is hereby certified that the amounts required to meet the contracts, agreements, obligation payments, or expenditures for the

operations of the said City, be lawfully appropriated or authorized or directed for such purpose and was in the Treasury or was in the process of collection to the credit of the funds listed and was free from any obligation or certification now and then outstanding.
