.A RESOLUTION DETERMINING TO PROCEED WITH THE EMPLOYMENT OF A PROFESSIONAL QUALIFIED SERVICE PROVIDER TO PREPARE A STRATEGIC GROWTH PLAN AND FINANCIAL ANALYSIS FOR THE CITY OF CIRCLEVILLE TO IDENTIFY OPPORTUNITIES AND STRATEGIES FOR REVENUE POSITIVE GROWTH FOR THE CITY OF CIRCLEVILLE.

WHEREAS, Council has previously adopted and implemented a comprehensive plan and a land use plan to serve as a frame work for city leaders for future planned organized expansion and strategic economic growth of the city; and

WHEREAS, since the establishment and utilization of these plans, the city has faced significant economic hardships due to the downsizing and actual closure of several large manufacturing facilities within and around the city which has resulted in the loss of numerous jobs of city residents and the change of the entire income demographic of the city; and

WHEREAS, Council recognizes the need to identify what opportunities exist and what strategies need to be implemented to insure appropriate mechanism are in place to provide to revenue and a positive orderly growth for the city; and

WHEREAS, to accomplish these goals for planned development, Council recognizes the need for the employment of a professional qualified service provider to prepare comprehensive physical analysis and strategic growth plan for the city.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, PICKAWAY COUNTY, OHIO AS FOLLOWS:

SECTION I: That Council hereby determines to proceed with the employment of a professional qualified service provider to prepare a strategic growth plan and financial analysis for the City of Circleville to identify opportunities and strategies for revenue positive growth for the City.

SECTION II: The Council further authorizes the president of council to take all action necessary to establish a committee for the development of the required qualifications for the professional service provider, to draft an appropriate request for quotes for this position, to establish a recommended format to be used in evaluating applicants, to interview qualified candidates, and to submit a recommendation for the employment of the most qualified person to provide these professional services on behalf of the city.

SECTION III: This resolution shall take effect and be in force from and after the earliest period permitted by law.
