

Ordinance No. 12 - 70 - 2021

A FINAL RESOLUTION AUTHORIZING OHIO DEPARTMENT OF TRANSPORTATION (ODOT) TO REPLACE CONCRETE ARCH STRUCTURE OVER HARGUS CREEK ALONG SR 188 WITHIN THE CITY LIMITS AS PART OF THE PROJECT PID 96270, PIC 188 0.22 AND DECLARING AN EMERGENCY.

WHEREAS, ODOT requires a final resolution enacted by the City of Circleville, hereinafter referred to as the Legislative Authority / local Public Agency or "LPA", in the matter of the stated described project.

WHEREAS, on the 4th day of May, 2021, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project.

The project consists of replacing Bridge No. PIC-188-0025 (SFN 65012822) located on North Court Street (S.R. 188) over Hargus Creek and resurfacing North Court Street between Water Street and Ted Lewis Drive, including approach work, water line and sanitary sewer replacement, signage, and pavement markings, lying within the City of Circleville; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the city limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U. S. Department of Transportation.

The share of the cost of the LPA is now estimated in the amount of **Three Thousand Six Hundred Sixty-Six and 00/100 Dollars (\$3,660.00)**, but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs ae determined; and

WHEREAS, the Director pf Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, the LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Circleville, County of Pickaway, State of Ohio, as follows:

SECTION I: That the estimated sum of Three Thousand Six Hundred Sixty-Six and 00/100 Dollars (\$3,660.00) is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from Federal funds.

SECTION II. That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

SECTION III. That the LPA enter into a contract with the State, and that the Director of Public Service be, and is hereby authorized to execute said contract, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.

	SECTION IV. Upon completion of the project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the project in accordance with all applicable rate and federal laws, including, but not limited to, Title 23, U.S.C., Section 116; (2) provide ample financial resources, as necessary, for the maintenance of the project; (3) maintain the right-of-way, keeping it free of obstructions, and (4) hold said right-of-way inviolate for public highway purpose.	
	SECTION V. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.
