Ordinance No. 01-06- 2016 Passed 1-19- 16

AN ORDINANCE AUTHORIZING THE MAYOR AND LAW DIRECTOR TO ENTER INTO A CONTRACT WITH THE PICKAWAY COUNTY COMMISSIONERS TO PROVIDE CANINE CONTROL SERVICES TO THE CITY FROM JANUARY 1, 2016 THROUGH DECEMBER 31, 2016 AND DECLARING AN EMERGENCY.

WHEREAS, the City of Circleville is currently being provided canine control services by the County Dog Warden and his deputies pursuant to Section 955.01 to 955.18 of the Ohio Revised Code; and

WHEREAS, the Pickaway County Commissioners have agreed to continue to provide such canine control services to the City in consideration of certain payment from the City for said services; and

WHEREAS, to obtain the necessary canine control services of the County Dog Warden and to insure the protection of the citizens of the City of Circleville, it is necessary to authorize the Mayor and the City Law Director to enter into contracts for such continued services; and

WHEREAS, entering into contracts with the Pickaway County Commissioners to provide such canine control services will not be detrimental to the citizens of the City of Circleville and the same ought to be done;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Circleville, Pickaway County, State of Ohio, as follows:

SECTION I. That the Mayor and the Law Director of the City of Circleville are hereby authorized to enter into contracts with the Pickaway County Commissioners to provide for canine control services to the City by the County Dog Warden pursuant to Sections 955.01 to 955.18 of the Ohio Revised Code with the term of these contracts to be in effect for a period commencing January 1, 2016 and continuing until December 31, 2016. In consideration of providing the above canine control services by the Pickaway County Commissioners through the County Dog Warden, the City shall pay to the Pickaway County Board of Commissioners the sum of \$12,500.00 for said services. Payment for the contract for the calendar year of 2016 shall be paid on or before December 31, 2016.

SECTION II. That there is hereby appropriated the sum of \$12,500.00 from General Fund Account Number 101.0135.55010 for the payment of such canine control services for the calendar year of 2016

SECTION III. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the City of Circleville and its inhabitants due to the immediate need to provide canine control services to the City, which services will not otherwise be provided by the County, so that this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor.

CANINE CONTROL SERVICES CONTRACT
Between Pickaway County Board of Commissions and the City of Circleville

This contract is made and entered into at Circleville, Pickaway County, Ohio, this 27th day of October, 2015, by and between the Pickaway County Board of Commissioners, hereinafter referred to as "Commissioners" and the City of Circleville, hereinafter referred to as the "City".

WHEREAS, the Commissioners have agreed to continue to provide canine control service to the City pursuant to §955.01 to 955.18 of the Ohio Revised Code in consideration of receipt from the City of Circleville certain sums for such services.

NOW, THEREFORE, it is mutually agreed between the parties hereto as follows:

SECTION I: That the Commissions hereby agree to continue to provide animal control services to the City pursuant to § 955.01 to 955.18.

SECTION II: That the Dog Warden will respond, with immediate dispatch, to the following situations within the City limits; a dog acting aggressive towards a person or another animal or if a dog may cause an accident by entering roadways.

SECTION III: That in consideration of continuing to receive canine control services from the Commissioners, the City hereby agrees to pay to the Commissioners the sum of \$12,500 per year period of one year for such services, to be paid in full on or before February 1st of each year this contract is in effect.

SECTION IV: That this contract will be in effect from January 1, 2016 through December 31, 2016.

IN WITNESS WHEREOF, the parties have hereunto set their hands by and through its representatives as authorized pursuant to ordinance and resolution of the respective bodies on the day and year last aforesaid.
