Ordinance No. 03-09 2019Passed 3-19- 2019

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO AND EXECUTING A MEMBERSHIP AGREEMENT ON BEHALF OF THE CITY OF CIRCLEVILLE WITH THE OHIO PLAN RISK MANAGEMENT FOR THE PURPOSE OF PROPERTY AND CASUALTY COVERAGE THROUGH THE OHIO PLAN RISK MANAGEMENT AND DECLARING AN EMERGENCY.

WHEREAS, the City of Circleville is desirous of becoming a member of the Ohio Plan Risk Management, Inc.; and

WHEREAS, the City of Circleville has a continuing duty to maintain and provide liability coverage comprised of general liability coverage, public official coverage, law enforcement coverage, additional liability coverage, crime coverage and blanket bonds for all public property and employees; and

WHEREAS, the City has determined it is in the best interest of the citizens of the City of Circleville to become a member of the Ohio Plan Risk Management Plan to provide liability and property insurance coverage.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Circleville, Pickaway County, Ohio, as follows:

SECTION I. That the Mayor is hereby authorized and directed to enter into and execute a membership agreement with the Ohio Government Risk Management Plan for the period of February 18, 2019 through February 18, 2020 for a sum not to exceed \$134,410.00.

SECTION II. That after having reviewed the terms contained the Code of Regulations of the Ohio Plan Risk Management, Inc. the City of Circleville agrees to join the Ohio Plan Risk Management, Inc.; accepts and agrees to abide by the Code of Regulations of the Ohio Plan Risk Management, Inc.; acknowledges receipt of the Ohio Plan Risk Management, Inc.'s Code of Regulations and has taken all action in accordance with law to enact this Ordinance after review of the terms contained in Code of Regulations of the Ohio Risk Management Plan.

SECTION III. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of council, and that all deliberations of the Council and any of the decision making bodies of the City of Circleville which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

SECTION IV. That this Ordinance is hereby declared to be an emergency measure, necessary for preservation of health, safety and welfare of the citizens of the City of Circleville, such emergency arising out of the immediate need to pass this Ordinance prior to the expiration of the City's previous insurance policy so as to insure continued property and casualty coverage, so this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
