Ordinance No. 03-13- 2019 Passed 3-19- 20 19

AN ORDINANCE AMENDING SECTION 1501.01 OF THE CODIFIED ORDINANCES OF THE CITY OF CIRCLEVILLE TO ADOPT THE 2017 OHIO FIRE CODE (OFC), AS ESTABLISHED BY THE OHIO DIVISION OF THE STATE FIRE MARSHAL, DEPARTMENT OF COMMERCE, AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of Circleville has previously adopted the 2011 Edition of the Ohio Fire Code (OFC), as established by the Ohio Division of the State Fire Marshal, Department of Commerce and set forth in Section 1501.01 of the Codified Ordinance of the City of Circleville; and

WHEREAS, the Ohio Division of the State Fire Marshal, Department of Commerce, has modified the entire Ohio Fire Code, thereby rendering it necessary to now adopt the 2017 Ohio Fire Code for enforcement purposes within the Municipality;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Circleville, County of Pickaway, and State of Ohio as follows:

SECTION I. That Section 1501.01 of Codified Ordinances of the City of Circleville is hereby amended so as to provide as follows:

1501.01 ADOPTION

There is hereby adopted by the municipality, the 2011 Ohio Fire Code (OFC) as established by the Ohio Division of State Fire Marshal, Department of Commerce, effective immediately, and as published in Division 1301:7 of the Ohio Administrative Code (OAC).

SECTION II. That any previous Ordinance in conflict with this Ordinance is hereby repealed and has no further force or effect. All remaining portions of any other Ordinance not modified by this Ordinance shall remain in full force and effect.

SECTION III. That this ordinance is hereby declared to be an emergency measure, necessary for the protection of the public, peace, health and safety of the residents of the City of Circleville, such emergency arising out of the immediate need to ensure the enforceability of the current Ohio Fire Code, so that this ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
