Ordinance No. 05 - 17 - 2019

Passed 5-7, 2019

A RESOLUTION AUTHORIZING THE DOWNTOWN BUSINESS ASSOCIATION RETAIL MERCHANTS, A DIVISION OF THE PICKAWAY COUNTY CHAMBER OF COMMERCE, TO UTILIZE A PORTION OF CITY SIDEWALKS, STREETS AND ALLEYS FOR THEIR EVENTS FOR 2019 AND DECLARING AN EMERGENCY.

WHEREAS, the Downtown Business Association/Retail Merchants desire to use downtown sidewalks for their Mothers' Day Out and Chocolate Walk on May 11, 2019.

WHEREAS, the Downtown Business Association/Retail Merchants desire to use the downtown sidewalks for their Open Air Street Market on June 1, 2019.

WHEREAS the Downtown Business Association/Retail Merchants desire to use downtown sidewalks for their Summer Sizzler Sidewalk Sales on July 18, 19 and 20, 2019.

WHEREAS, the Downtown Business Association/Retail Merchants desire to use downtown sidewalks, alleys and streets for their Autumn Arts, Crafts Fair on September 7, 2019.

WHEREAS, the Downtown Business Association/Retail Merchants desire to use downtown sidewalks for their Halloween Fun Night on October 29, 2019.

WHEREAS, the Downtown Business Association/Retail Merchants desire to use downtown sidewalks on West Main Street for their Winter Carnival and the downtown streets for their Home Town Christmas Parade on December 1, 2019

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Circleville, County of Pickaway, State of Ohio, as follows:

SECTION I: That the Downtown Business Association/Retail Merchants be, and is hereby authorized to utilize the downtown sidewalks on West Main Street from Scioto Street to Court Street, South Court Street from Main Street to Franklin Street and North Court Street from Main Street to Pinckney Street for their Mothers' Day Out on May 11, 2019 from 11:00 a.m. until 5:00 p.m. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various streets.

SECTION II. That the Downtown Business Association/Retail Merchants be, and is hereby authorized to utilize the downtown sidewalks on West Main Street from Scioto Street to Court Street, South Court Street from Main Street to Franklin Street and North Court Street from Main Street to Pinckney Street on June 1, 2019 from 9:00 am until 4:00 pm for their Open Air Street Market; with a rain date of June 15, 2019. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various streets.

SECTION III. That the Downtown Business Association/Retail Merchants be, and is hereby authorized to utilize downtown sidewalks on Court Street from Franklin Street to High Street and Main Street from Pickaway Street to Western Avenue on July 18, 19 and 20, 2019 from 10:00 am until 6:00 pm for their Summer Sizzler Sidewalk Sales. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various streets.

SECTION IV. That the Downtown Business Association/Retail Merchants be, and is hereby authorized to:

- a) utilize downtown sidewalks on West Main Street from Scioto Street to Court Street, South Court Street from Main Street to Franklin Street and North Court Street from Main Street to Pinckney Street, and
 - b) close the alley between 138 and 140 West Main Street
- on September 7, 2019 from 8:00 am until 5:00 pm for their Autumn Arts & Crafts Fair; with a rain date of September 14, 2019. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various streets.

SECTION V. That the Downtown Business Association/Retail Merchants be, and is hereby authorized to utilize downtown sidewalks on West Main Street from Scioto Street to Court Street, South Court Street from Main Street to Franklin Street and North Court Street from Main Street to Pinckney Street for their Halloween Fun Night on October 29, 2019 from 5:00 p.m. until 6:30 p.m.; with a rain date of October 30, 2019. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various streets.

SECTION VI. That the Downtown Business Association/Retail Merchants be, and is hereby authorized to

- a) utilize downtown sidewalks on West Main Street from Scioto Street to Court Street, South Court Street from Main Street to Franklin Street and North Court Street from Main Street to Pinckney Street for their Winter Carnival on December 1, 2019 from 1:00 p.m. until 4:00 p.m. and
- b) Close Pickaway Street from Main Street to Mound Street for lineup for their Home Town Christmas Parade on December 1, 2018 from 3:00 p.m. until 5:00 p.m.;

with a rain date of December 7, 2019. Upon Council's approval of resolution, the Directors of Public Service and Safety shall authorize the use and closing of various streets.

SECTION VII. That as a condition precedent to Section 1, the event sponsor shall maintain a Two Million Dollar (\$2,000,000) Certificate of Liability Insurance for the protection of the City of Circleville, Ohio, indemnifying and saving harmless the said City, from any liability that may arise or accrue by reason of the temporary use of the sidewalks, streets and alleys the event sponsor shall present a copy of said insurance, naming the City as an additional insured, to the Auditor of the City of Circleville, Ohio for approval prior to said event..

SECTION VIII. That this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Circleville; the emergency being to avoid unnecessary delay in the application process; wherefore, this Resolution shall be in full force and effect immediately upon the passage.
