## **RECORD OF ORDINANCES**

Ordinance No. <u>05-18-</u> 2019 Passed <u>5-7</u> , 20 <u>19</u>
A RESOLUTION AUTHORIZING THE CIRCLEVILLE PUMPKIN SHOW, INC. TO OPERATE THE ANNUAL "CIRCLEVILLE PUMPKIN SHOW" ON VARIOUS STREETS AND SIDEWALKS OF THE CITY OF CIRCLEVILLE, OHIO.
<b>WHEREAS,</b> the annual Circleville Pumpkin Show is to be held Wednesday thru Saturday, October 16, 17, 18, and 19, 2019; and preview night will be on Tuesday, October 15, 2019; and
<b>WHEREAS,</b> said "Circleville Pumpkin Show" is a civic endeavor for the benefit of the citizens of the City of Circleville, Ohio; <b>and</b>
<b>WHEREAS</b> , the Council and Mayor of the City of Circleville, Ohio desire to express their approval on behalf of the citizens of the City of Circleville, Ohio and to authorize the use and control of various city streets, alleys and sidewalks as well as the use of equipment and personnel as mutually agreed to by the City of Circleville and Circleville Pumpkin Show, Inc. for the benefit of this annual show;
NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, COUNTY OF PICKAWAY, STATE OF OHIO, AS FOLLOWS:
<b>SECTION I.</b> The boundaries of various streets, alleys and sidewalks for the use of and under the control of Pumpkin Show, Inc. include those streets, alleys and sidewalks inside the boundaries formed by the north side of Mound Street from the east side of South Western Avenue to the west side of South Washington Street; the east side of Western Avenue from the north side of West Mound Street to the south side of West High Street; the south side of High Street from the east side of North Western Avenue to the west side of North Washington Street; and the west side of Washington Street from the south side of East High Street to the north side of East Mound Street. A boundary may be extended to accommodate unforeseen circumstances after approval is granted from the Director of Public Safety and Section II requirements are fulfilled.
<b>SECTION II.</b> That as a condition precedent to Section I, the event sponsor shall maintain a Two Million dollar (\$2,000,000) Liability Insurance Certificate for the protection of the City of Circleville, Ohio, indemnifying and saving harmless the said City from any liability that may arise or accrue by reason of the temporary closing/use of the street(s) or other thoroughfare, and the event sponsor shall present a copy, naming the City as an additional insured, to the Auditor of the City of Circleville, Ohio for approval prior to said event.
<b>SECTION III</b> That the annual Circleville Pumpkin Show operated by Circleville Pumpkin Show, Inc. on October 16, 17, 18, and 19, 2019 be and hereby is authorized to operate and control said show upon the various streets, alleys, sidewalks as well as the use of equipment and personnel of the City of Circleville, Ohio. That to effect said Circleville Pumpkin Show, the Directors of Public Service and Safety shall authorize the closing of various streets or limiting of traffic from 8:00 PM Saturday, October 12, 2019 through Sunday, October 20, 2019.
<b>SECTION IV.</b> That this Resolution shall take effect and be in force from and after its passage and approval by the Mayor.
