AN ORDINANCE AMENDING SECTIONS 131.03(b)(3), AND 351.18(b)(4) MODIFYING OR ESTABLISHING FEES FOR VARIOUS PERMITS WITHIN THE MUNICIPALITY.

WHEREAS, the Council of the City of Circleville is empowered by statute to modify and establish permit fees within the municipality; and

WHEREAS, Council has determined the need to modify or establish certain permit fees within the municipality; and

WHEREAS, Council believes that these permit fees will not be detrimental to the public, and that it is in the best interests of the citizens of the City of Circleville, and that the same ought to be done.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, PICKAWAY COUNTY, OHIO, AS FOLLOWS:

SECTION I. That Section 131.03(b)(3) of the Codified Ordinances of the City of Circleville is hereby modified so as to provide as follows:

131.03 ALARM SYSTEMS

(b)(3) An alarm permit fee of \$20.00 shall be charged annually for a permit issued under this section. An alarm permit shall be deemed renewed when the annual alarm permit fee is remitted to the city and the system has been approved by the appropriate chief.

SECTION II. That Section 351.18(b)(4) of the Codified Ordinances of the City of Circleville is hereby modified so as to provide as follows:

351.18 RESIDENTIAL HANDICAPPED PARKING SPACES

(b)(4) Application/parking permit. A severely handicapped person, or their delegate, may secure an application for the residential handicapped parking space by contacting the Police Chief. The completed application must be delivered to the Police Department. The application will be reviewed by the Chief of Police, Director of Public Safety and the Director of Public Service; and, a determination made concerning the residential parking space. If the application is approved, the applicant must pay a permit fee of \$250.00 to the Police Department and secure a "restricted parking" permit from the Police Department receptionist. The permit will be assigned a number to correspond with the number to be assigned to the painted space and will identify the vehicle authorized to use the parking space.

SECTION II. The permit fees set forth in SECTIONS I, and II of this ordinance shall be non-refundable.

SECTION III. That this ordinance shall take effect and be in force from and after the earliest period permitted by law.
