A RESOLUTION AUTHORIZING THE PICKAWAY COUNTY VISITORS BUREAU TO USE THE ADMINISTRATION PARKING LOT, BUCKEYE ALLEY, AND POPLAR ALLEY, BETWEEN EAST FRANKLIN STREET TO THE NORTH SIDE OF BUCKEYE ALLEY, FROM 8:00 A.M. TO 11:00 P.M., ON THURSDAY, JUNE 19, JULY 17, AUGUST 21 AND SEPTEMBER 18, 2014 FOR THE PURPOSE OF THE THIRD THURSDAY EVENTS.

WHEREAS, the Pickaway County Visitors Bureau desires to use the Administration parking lot, Buckeye Alley and Poplar Alley, between East Franklin Street to the north side of Buckeye Alley, from 8:00 a.m. to 11:00 p.m., on Thursday, June 19, July 17, August 21 and September 18, 2014 or the following Friday or Saturday of each date as rain dates, for the purpose of the Third Thursday Event Series; and

WHEREAS, the temporary closing of the parking lot and use of the alley is deemed to be in the best interest of the community and provide an additional measure of safety to participants;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, COUNTY OF PICKAWAY, STATE OF OHIO, AS FOLLOWS:

SECTION I. That the Pickaway County Visitors Bureau be, and is hereby, authorized to use the Administration parking lot, Buckeye Alley and Poplar Alley, between East Franklin Street to the north side of Buckeye Alley, from 8:00 a.m. to 11:00 p.m., on Thursday, June 19, July 17, August 21 and September 18, 2014 or the following Friday or Saturday of each date as rain dates, for the purpose of the Third Thursday Event Series. Upon Council's approval of this Resolution, the Mayor may authorize the closing of the Administration parking lot, Buckeye Alley, and Poplar Alley in between East Franklin Street to the north side of Buckeye Alley during this period.

SECTION II. That as a condition precedent to Section I, the event sponsor shall maintain liability insurance for the protection of the City of Circleville, Ohio, indemnifying and saving harmless the said city from any liability that may arise or accrue by reason of the temporary closing/use of the streets or other thoroughfares, and the event sponsor shall present a copy of said insurance to the Auditor of the City of Circleville, Ohio for approval prior to said event.

SECTION III. That this resolution shall take effect and be in force at the earliest period allowed by law.
