Ordinance No. 03-24-2014Passed 3-18, 2014

A RESOLUTION AUTHORIZING THE PICKAWAY COUNTY VISITORS BUREAU TO USE THE CITY ADMINISTRATION PARKING LOT, LOCATED AT 120 EAST FRANKLIN STREET, DURING THE 2014 PUMPKIN SHOW FOR THE PURPOSE OF THE CIRCLEVILLE-PICKAWAY VISITORS PAVILION.

WHEREAS, the Pickaway County Visitors Bureau desires to use the City Administration Parking Lot, located at 120 East Franklin Street, from Friday, October 10, 2014 thru Sunday, October 19, 2014 to erect a tent to include a stage for various groups to perform during the 2014 Pumpkin Show; and

WHEREAS, the use of the parking lot is in the best interest of the community and provides additional entertainment to the show; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, COUNTY OF PICKAWAY, STATE OF OHIO, AS FOLLOWS:

SECTION I. That the Pickaway County Visitors Bureau be, and is hereby, authorized to use the City Administration Parking Lot, located at 120 East Franklin Street, during the 2014 Pumpkin Show, for the purpose of the Circleville-Pickaway Visitors Pavilion to provide a tent to include a stage for live entertainment. Upon Council's approval of this Resolution, the Mayor may authorize the use during this period. The Directors of Public Service and/or Safety may authorize the closing of various streets or limiting traffic through the administrative parking lot from Friday, October 10, 2014 thru Sunday, October 19, 2014.

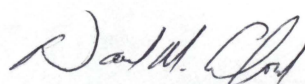
SECTION II. That as a condition precedent to Section I, the Visitors Bureau shall maintain liability insurance for the protection of the City of Circleville, Ohio, indemnifying and saving harmless the said city from any liability that may arise or accrue by reason of the use of the parking lot, and the Visitors Bureau shall present a copy of said insurance to the Auditor of the City of Circleville, Ohio for approval prior to said event.

SECTION III. That this resolution shall take effect and be in force at the earliest period allowed by law.

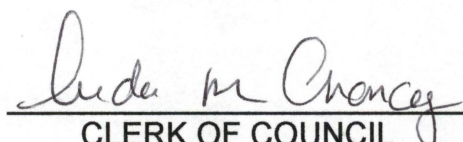

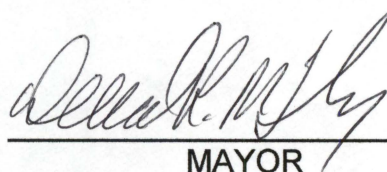

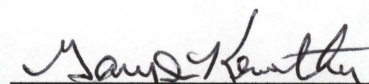
