AUTHORIZING DOWNTOWN THE RESOLUTION ASSOCIATION/RETAIL MERCHANTS, A DIVISION OF THE CIRCLEVILLE-PICKAWAY CHAMBER OF COMMERCE TO USE THE SIDEWALKS ON COURT STREET FROM MOUND STREET TO HIGH STREET AND MAIN STREET FROM WASHINGTON STREET TO WESTERN AVENUE ON SATURDAY, SEPTEMBER 14, 2002 (RAIN DATE IS SATURDAY, SEPTEMBER 21, 2002) FROM 8:00 A.M. TO 6:00 P.M. FOR THE PURPOSE OF AN ARTS & CRAFTS FAIR.

WHEREAS, the Downtown Business Association/Retail Merchants desires to use the sidewalks on Court Street from Mound Street to High Street and Main Street from Washington Street to Western Avenue on Saturday, September 14, 2002 (Rain Date is Saturday, September 21, 2002) from 8:00 a .m. to 6:00 p.m. for the purpose of an Arts & Crafts Fair; and

WHEREAS, the temporary closing and use of the street(s), sidewalks, and/or thoroughfares is deemed to be in the best interest of the community and provide an additional measure of safety to participants; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Circleville, County of Pickaway, State of Ohio, as follows:

SECTION I. That the Downtown Business Association/Retail Merchants be, and is hereby, authorized to use the sidewalks on Court Street from Mound Street to High Street and Main Street from Washington Street to Western Avenue on Saturday, September 14, 2002 (Rain Date is Saturday, September 21, 2002) from 8:00 a.m. to 6:00 p.m. for an Arts & Crafts Fair. Upon Council's approval of this Resolution, the Mayor may authorize the use of the sidewalks on Court Street from Mound Street to High Street and Main Street from Washington Street to Western Avenue during this period.

SECTION II. That as a condition precedent to Section I, the event sponsor shall maintain liability insurance for the protection of the City of Circleville, Ohio, indemnifying and saving harmless the said City from any liability that may arise or accrue by reason of the temporary closing/use of the street(s), sidewalks, or other thoroughfares, and the event sponsor shall present a copy or said insurance to the Auditor of the City of Circleville, Ohio for approval prior to said event.

SECTION III. That this resolution shall take effect and be in force immediately from and after it's adoption by Council.
