A RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO APPLY FOR, ACCEPT, AND ENTER INTO AN OHIO WATER DEVELOPMENT AUTHORITY (OWDA) DESIGN LOAN AGREEMENT ON BEHALF OF THE CITY OF CIRCLEVILLE FOR THE DESIGN OF NEW WATER FACILITIES FOR THE NORTHSIDE WATERLINE PROJECT; DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Circleville seeks to improve its existing water facilities in the Northside Waterline Project area, including Lincoln Dr., Sunshine St., Pershing Dr., Lynwood Ave., Georgia Rd., Mulberry St., Dartmouth Rd., and N. Court St.; and

WHEREAS, the City of Circleville intends to apply for an Ohio Water Development Authority (OWDA) loan for the design of the aforementioned water facilities; and

WHEREAS, the Ohio Water Development Authority (OWDA) requires the government authority to pass legislation for the application of a loan and the execution of an agreement as well as designating a dedicated repayment source.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, COUNTY OF PICKAWAY, STATE OF OHIO AS FOLLOWS:

SECTION I. That the Director of Public Service is hereby authorized to contract with STRAND, Associates for the design of these improvements and apply for an OWDA loan, sign all documents for, and enter into an Ohio Water Development Authority (OWDA) loan agreement with the Ohio Environmental Protection Agency for the design of water facilities on behalf of the City of Circleville, Ohio.

SECTION II. That the dedicated source of repayment will be Water Maintenance and Distribution Fund Account 819.

SECTION III. That this resolution is hereby declared to be an emergency measure necessary for the preservation of health, safety, and welfare of the citizens of the City of Circleville, such emergency arising out of the immediate need to authorize the Director of Public Service to enter into this loan agreement prior to the commission deadlines for this loan, so that this ordinance shall take effect and be in force immediately from and after its passage and approval..
