## A RESOLUTION AUTHORIZING AND DIRECTING THE PAYMENT OF MONIES TO THE ACTING/APPOINTED TREASURER FOR SERVICES RENDERED TO THE CITY OF CIRCLEVILLE AND DECLARING AN EMERGENCY.

**WHEREAS**, the candidate elect for the elected position of Treasurer for the City of Circleville is no longer eligible to hold such office; and

**WHEREAS**, the position of Treasurer will necessitate an acting/appointed Treasurer until such time as the affiliated County Political Party Central Committee appoints a permanent Treasurer; and

**WHEREAS**, City Council and the Mayor believe it is appropriate that an individual serve in the capacity of acting appointed treasurer; and

**WHEREAS**, City Council and the Mayor desire jointly to compensate the acting/appointed Treasurer at the same rate of compensation as the elected Treasurer would have received; and

**WHEREAS**, Council and the Mayor of the City of Circleville believe in the continuation of the previously elected treasurer will necessitate without undue burden the functions of the office of the treasurer thus benefitting the citizens of the City of Circleville without undue burden or delay.

### **NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, COUNTY OF PICKAWAY, STATE OF OHIO AS FOLLOWS:**

**SECTION I:** The compensation to be paid to the acting/appointed Treasurer for the City of Circleville is set by Council at the same rate as was set for the previously elected Treasurer.

**SECTION II:** The acting/appointed Treasurer is authorized to pay themselves at an amount equal to the amount set by Council for the salary of the elected Treasurer until such time that a predecessor can be appointed.

**SECTION III:** Therefore, Dodie Radcliff previously elected Treasurer shall be appointed by the agreement of City Council and the Mayor of the City of Circleville, to serve as Acting Treasurer of the City of Circleville until such time that a predecessor can be appointed consistent with Ohio Revised Code Chapter 733.

**SECTION IV:** This resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Circleville; the emergency being to avoid unnecessary delay of processing funds for the City of Circleville, wherefore, this resolution shall be in full force and effective immediately upon its passage.
