THE PURPOSE OF CONDUCTING A SALE OF MERCHANDISE.~~

Whereas, the Downtown Business Association/Retail Merchants desire to use South Court Street between Main and Franklin Streets on Saturday, September 7, 1991, (Raindate September 14) from 7:00 A.M. to 7:00 P.M.; and

Whereas, the Downtown Business Association/Retail Merchants is an organization endeavoring to better the City of Circleville, Ohio; and

Whereas, the Council and Mayor of the City of Circleville, Ohio desires to express their mutual approval on behalf of the citizens of Circleville, Ohio, and to authorize the use of South Court Street for the benefit of the Community:

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, STATE OF OHIO:

SECTION I: That the Downtown Business Association/Retail Merchants be and is hereby authorized to use South Court Street between Main and Franklin Streets from 7:00 A.M. to 7:00 P.M. on Saturday, September 7, 1991, (Raindate September 14). That to effect said use, the Mayor may authorize the closing of South Court Street or limiting of traffic from and after September 7, 1991, (Raindate September 14).

SECTION II: That, as a condition precedent to Section I, above, the Downtown Business Association/Retail Merchants shall maintain liability Insurance for the protection of the City of Circleville, Ohio, indemnifying and saving harmless the said City from any and all liability that may arise or accrue by reason of the use of South Court Street and shall present a copy of said insurance to the Auditor of the City of Circleville, Ohio, for approval.

SECTION III: That this resolution shall take effect and be in force from and after its passage and approval.
