## 2025 CIRCLEVILLE CITY COUNCIL

---

Circleville City Council serves as the primary legislative authority for the City of Circleville, exercising all legislative powers vested in the municipality under Ohio law. Its duties are predominantly legislative in nature and include enacting ordinances and resolutions, appropriating funds for city operations, adopting the annual city budget, approving labor contracts, and appointing members to various city boards and commissions.

Council consists of seven elected members serving two-year terms: three elected at-large by the City's entire voting population and one from each of the four wards. The Council President, also elected citywide for a two-year term, presides over Council sessions and serves as a non-voting member of all committees.

Regular Council meetings are held on the first and third Tuesdays of each month at 7:00 p.m. in the Council Chamber, located on the second floor of the City Administration Building at 127 South Court Street, Circleville, Ohio 43113.

# 2025 CITY COUNCIL COMMITTEES

---

## **COMMITTEE OF THE WHOLE**

*The Committee of the Whole handles major enterprise-wide initiatives, legislative and organizational issues, standards and rules, commission appeals process, consideration, modification and actions of the City's vision, goals and strategic direction. This committee also oversees the Circleville - Pickaway Lease Oversight Committee and the Joint Economic District Board*

## **FINANCE COMMITTEE**

*The Finance Committee handles the annual budget for the city, expenditures from unappropriated funds, alternative revenues sources and methods, internal fiscal compliance, issuance and rollover of notes, funding for new positions, wage, salary and benefit adjustments, and income tax collection.*

## **JUDICIAL COMMITTEE**

*The Judicial Committee handles municipal court, civil liability, public health problems and nuisance abatement, the Health Department contract, ordinance appeals and amendments, zoning code and amendments, the Board of Zoning Appeals, rezoning, and cable television.*

## **SAFETY COMMITTEE**

*The Safety Committee handles Operation needs for the safety forces, purchases of safety equipment, fire and police buildings, training expenditures, tornado sirens, disaster preparedness and business continuity, traffic safety controls, and parking.*

## **SERVICE COMMITTEE**

*The Service Committee handles operational needs for service and utility departments, water treatment and wastewater treatment, flood and drainage control projects, sanitary and storm sewer projects, infrastructure improvements, utility rates and tap fees, traffic flow and control, parking and street or alley vacation, street and alley repair, and sidewalks.*

## **STRATEGIC PLANNING COMMITTEE**

*The Strategic Planning Committee handles planning for municipal needs, including land use or acquisition, annexation, and office space, in addition to developing, maintaining, and reviewing the comprehensive plan for the city, park and trail development and maintenance, economic development initiatives including P3 contracting, and the sale, lease or use of city property. This committee works with the Historic Review Board, the Tree Commission, and the Downtown Redevelopment District Board, as well as information technology and the city's website.*

## 2025 COUNCIL & COMMITTEE MEETINGS

---

Pursuant to Section 705.22 of the Ohio Revised Code, this annual report of the Circleville City Council is hereby filed for public inspection. This annual report is on file with the Clerk of Council and posted online on the City of Circleville website for public access.

City Council is responsible for overseeing and allocating funds to support the City's operations and priorities. In 2025, the approved budget totaled \$57,193,905.91, representing a decrease of approximately \$6.85 million (or 10.7%) from the 2024 budget of \$64,042,994.03.

In January 2025, the City Council was organized with Barry Keller serving as Council President.

City Council President serves as a non-voting member of all committees. President Pro-Tempore was Sheri Theis. Council was organized into the following six committees:



During the 2025 calendar year, Council enacted 103 pieces of legislation. Council members participated in a total of 88 meetings, including regular sessions, special sessions, public hearings, and committee meetings. The average attendance rate for all Council and Committee meetings was 88%.

# 2025 HISTORIC LEGISLATION PRESERVATION AND DIGITIZATION PROJECT

In 2025, the City of Circleville successfully completed a comprehensive initiative to preserve and digitize its historic legislative records, significantly enhancing both archival integrity and public accessibility. Partnering with the nationally recognized HF Group, the City conserved and digitized dozens of fragile bound volumes dating back to the 1880s, including early ordinance books and council proceedings, through professional treatments such as surface cleaning, de-acidification, mending, Mylar encapsulation, rebinding, and high-resolution scanning. Additionally, thousands of loose legislative documents from the 1930s through 2024 were collated, scanned, indexed, and securely rehoused in archival enclosures. This multi-phase effort culminated in the launch of the new City of Circleville Legislation webpage on the City's website—a custom-designed, mobile-responsive platform. The webpage features advanced search and filtering capabilities, organized accordion-style listings by year, and direct download options for ordinances and resolutions, making decades of legislative history easily accessible to residents, researchers, and staff for the first time. This project not only safeguards irreplaceable historical records but also promotes greater government transparency and community engagement.





