## AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACTS FOR THE 2026 STREET, UTILITY, PARKS, BUILDING AND TRAFFIC SIGNAL IMPROVEMENT AND MAINTENANCE PROGRAM AND DECLARING AN EMERGENCY.

**WHEREAS**, the condition of various streets, parks, traffic signals, water mains, sanitary, storm sewers, building, water and wastewater treatment facilities, require maintenance and construction work to be performed on them in order to provide a safe environment and adequate streets; and

**WHEREAS**, it will be necessary to contract for professional services to include engineering and project management/inspections.

### NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, COUNTY OF PICKAWAY, STATE OF OHIO, AS FOLLOWS:

**SECTION I.** That the Director of Public Service is hereby authorized to advertise for bids and enter into various contracts for the rejuvenation, slurry sealing, base and curb repair, resurfacing, road reconstruction, crack sealing, traffic striping, traffic signalization, water main repair, sanitary and storm sewer repair, water and wastewater facilities repair, park repairs, building maintenance and other maintenance work as required on various sewers, streets, alleys, buildings and parks within the City of Circleville.

**SECTION II.** That the Director of Public Service is hereby authorized to contract for professional services to include engineering and inspections in conjunction with the stated various contracts.

**SECTION III.** This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Circleville; the emergency being to avoid unnecessary delay in the application and contracting process, wherefore, this ordinance shall be in full force and effective immediately upon its passage.




