A RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER POLLUTION CONTROL LOAN FUND (WPCLF) DESIGN LOAN AGREEMENT ON BEHALF OF THE CITY OF CIRCLEVILLE FOR THE DESIGN OF NEW TRUNK SEWER REGIONALIZATION FACILITIES; AND DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN AND DECLARING AN EMERGENCY.

WHEREAS, the City of Circleville seeks to improve its existing wastewater facilities; and

WHEREAS, the City of Circleville intends to apply for a Water Pollution Control Loan Fund (WPCLF) loan for the design of the aforementioned wastewater facilities; and

WHEREAS, the Ohio Water Pollution Control Loan Fund (WPCLF) requires the government authority to pass legislation for the application of a loan and the execution of an agreement as well as designating a dedicated repayment source.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, PICKAWAY COUNTY, OHIO, AS FOLLOWS:

SECTION I. That the Director of Public Service is hereby authorized to apply for a WPCLF loan, sign all documents for, and enter into a WPCLF loan agreement with the Ohio Environmental Protection Agency and the Ohio Water Development Authority for design of wastewater facilities on behalf of the City of Circleville, Ohio.

SECTION II. That the dedicated source of repayment will be Sanitary Sewer Fund Account 920.

SECTION III. That this resolution is hereby declared to be an emergency measure necessary for the preservation of health, safety, and welfare of the citizens of the City of Circleville, such emergency arising out of the immediate need to authorize the Director of Public Service to enter into this loan agreement prior to the commission deadlines for this loan, so that this resolution shall take effect and be in force immediately from and after its passage and approval.
