A RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER SUPPLY REVOLVING LOAN ACCOUNT (WSRLA) CONSTRUCTION LOAN AGREEMENT ON BEHALF OF THE CITY OF CIRCLEVILLE FOR THE CONSTRUCTION OF NEW WATER FACILITIES FOR THE NORTHSIDE WATERLINE PROJECT; TENTATIVELY AWARD THE NORTHSIDE WATERLINE PROJECT TO THE SUCCESSFUL BIDDER; AND DESIGNATING A DEDICATED REPAYMENT SOURCE FOR THE LOAN AND DECLARING AN EMERGENCY.

WHEREAS, the City of Circleville seeks to upgrade its existing water facilities on Atwater Avenue, Lincoln Drive, Dartmouth Road, Pershing Drive, and Sunshine Street; and

WHEREAS, the City of Circleville intends to apply for a Water Supply Revolving Loan Account (WSRLA) loan for the construction of the aforementioned water facilities; and

WHEREAS, the Ohio Water Supply Revolving Loan Account (WSRLA) requires the government authority to pass legislation for application of a loan and the execution of an agreement as well as designating a dedicated repayment source.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, PICKAWAY COUNTY, OHIO, AS FOLLOWS:

SECTION I. That the Director of Public Service is hereby authorized to apply for a WSRLA loan, to tentatively award the Northside Waterline Project contract to the successful bidder, and sign all documents for and enter into a Water Supply Revolving Loan Account (WSRLA) loan agreement with the Ohio Environmental Protection Agency and the Ohio Water Development Authority for construction of water facilities on behalf of the City of Circleville, Ohio.

SECTION II. That the dedicated source of repayment will be Water Maintenance and Distribution Fund Account 819.

SECTION III. That this resolution is hereby declared to be an emergency measure necessary for the preservation of health, safety, and welfare of the citizens of the City of Circleville, such emergency arising out of the immediate need to authorize the Director of Public Service to enter into this loan agreement prior to the commission deadlines for this loan, so that this resolution shall take effect and be in force immediately from and after its passage and approval.
